



The Grand-Ducal Regulation of 3 April 2020 derogating from the provisions of Articles 11, paragraph 2, 12, paragraph 3, 14, paragraph 2 and 428, paragraph 4 of the Social Security Code and L.121-6, paragraph 3 of the Labour Code derogates from three legal provisions:

- The mechanism for calculating the 78 weeks of incapacity for work due to illness is suspended from 18 March 2020 until end of the health crisis;
- The normal mechanism of burden-sharing for sickness benefit is derogated from;
- the CNS will pay the sickness cash benefit to the employees between 1st April 2020 and the end of the calendar month in which the state of crisis ends
- The calculation of default interest for late payment of social security contributions is suspended for the duration of the state of crisis.

## I. Payroll

If you have sick employees during the crisis, please send us an Excel file with:

- Id of employees/name of employees, period and hours of sickness.
- Based on this information, we will calculate/adjust the salaries for April and possibly subsequent months.
- The sickness indemnity will be paid directly by the CNS.
